All petitions must be signed by members, with complete addresses, and submitted to Jeff Taschner, DSEA Executive Director, 136 E. Water St., Dover, DE 19901, **no later than, December 11, 2017.**

Petitions must be accompanied by the following items:

- (1) **Candidates for DSEA TREASURER (3-year term)** -- a campaign statement and/or resume not exceeding 300 words and a photograph suitable for reproduction and dissemination to members through regular means of communication. Must have been an active member for at least two years and obtain a minimum of 50 signatures.
- (2) **Candidates for State Delegate to the NEA Representative Assembly (2-year term) (5 two-year term seats vacant)** -- a campaign statement and/or resume not exceeding 150 words and a photograph suitable for reproduction and dissemination to members through regular means of communication. Open to ALL members. Must obtain a minimum of 20 signatures.
- (3) **Candidates for DSEA Executive Board** -- a campaign statement and/or resume not exceeding 150 words and a photograph suitable for reproduction and dissemination to members through regular means of communication. Must have been a member for at least one year and work in the county in which you are pursuing a seat. The following vacancies exist for the DSEA Executive Board:

Kent County Seats Vacant: 2 full-term vacancies which the term will be 9/1/18 to 8/31/20

Sussex County Seats Vacant: 2 full-term vacancies which the term will be 9/1/18 to 8/31/20

New Castle County Seats Vacant: 5 full-term vacancies which the term will be 9/1/18 to 8/31/20
1 partial-term vacancy which will start with the announcement of the election results to 8/31/19

Board signatures must be from the County in which you are pursuing a seat. Must obtain a minimum of 20 signatures.

Statements and photographs will be posted on www.dsea.org by December 18th and will be sent with election ballots to all members on January 8, 2018. **Members seeking more than one office must submit a petition and statement for each office; however, one photograph is sufficient.** Photographs should be in color, **mailed with petition(s)**, or may be submitted electronically as .jpg files and e-mailed to Tammy Wagner at tammy.wagner@dsea.org.

To be valid, please write legibly. A minimum of **50 signatures** for DSEA Treasurer must be affixed to this petition by DSEA/NEA/Local Association members. Candidates for DSEA Executive Board and State Delegate to the NEA Representative Assembly must affix **20 signatures** to this petition from DSEA/NEA/Local Association members. ***It is recommended that candidates secure extra names since the entire petition could be declared invalid if just one name is illegible or otherwise invalid.***
